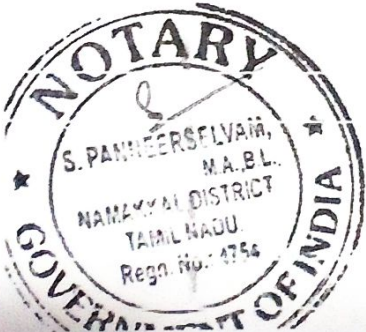

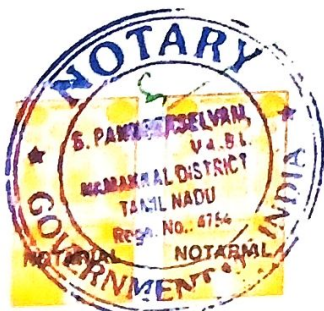
1. That Kongu Educational Charitable Trust is a registered Trust under the Indian Trust Act 1982.
